OLD BUSINESS

Village Update

Puchalla reported on the June 11th Village Board meeting. The Village will be receiving a free solar powered emergency siren. Lancaster County Emergency Management picks one community each year to receive a new siren and Roca will receive it. The new emergency siren will be moved and the old siren will be used for parts. Chuck and Frannie Green will be reimbursed for the electrical expenses for the current siren on their property. Lisa Schmutte will receive one half of the expenses of repairing and unclogging caused by her sewer backing up. The sewer line is in the Village right of way. Puchalla's and Dessel's reappointments for three year terms were approved. Tom Bliss from SENDD discussed requirements for the Village to receive assistance in applying for a CDBG Public Works grant. Verizon will pay Roca \$2,000 monthly. The Farmer's Coop contract was approved. The work on Main Street is to start June 25th.

NEW BUSINESS

New Bylaws

Puchalla stated the Committee needs to review the new October 2017 Draft of the Bylaws. She stated she had looked at the Draft twice and took notes. There is no section for Wind Turbines, tiny homes, agricultural event center, solar panels or food trucks. The Planning Commission decided earlier to keep the current zoning.
