APPROVAL OF MEETING MINUTES AND FINANCIAL REPORTS

JEO - APPROVAL OF PAY APPLICATION

Ossowski moved, seconded by Anderson to approve the Contractor's Application for Payment No. 4 dated 3/11/2019 in the amount of \$14,835.00 for the Main Street Project. Voting aye: Anderson, Green, Hemenway, Ossowski. Motion carried.

VILLAGE STREET IMPROVEMENT DISTRICT BANS

Ossowski moved, seconded by Anderson to approve the Village's Street Improvement District BANs in an amount not to exceed \$800,000. In April, when the Certificate of Substantial Completion is completed, a closing date will be set. Voting aye: Anderson, Green, Hemenway, Ossowski. Motion carried.

APPROVAL OF ZONING CHANGE FOR ROCA BERRY FARM

The Planning Commission recommended to the board that Roca Berry Farm be zoned Restricted Commercial for S19 T8 R7 Lots 20 & 21 NE to follow along the lines of current business. RBF may continue down the path they are heading as far as business ventures. For example, they can continue to do agriculture attractions and wedding venue things but they cannot put up a strip mall, car wash, dog kennel, etc. on their property. These were just examples-the board can refine if they shall choose to do so. All 80 acres of farmland & 64 acres of RBF would be included in this zoning change. Green moved, seconded by Ossowski to approve the recommendation. Voting aye: Anderson, Green, Hemenway, Ossowski. Motion carried.

INFORMATION, UPDATES & OTHER DISCUSSIONS

The deadline for the emergency siren has been extended due to weather. An update was given on any nuisances & complaints. Notification was given to the board that August 3rd and 4th Roca Berry Farms will be hosting a bike event. Gordon Tebo and Chip Tebo, members of the Roca Cemetery Association asked to be on the next agenda to discuss and consider the Village taking over the Cemetery.
