FARMERS COOP

As of February 24, 2020, the coop in Roca has closed grain operations.

PLUMBING INSPECTOR RETIREMENT

As of April 30, 2020, John Morris, the plumbing inspector for the Village is retiring. We will be seeking a replacement.

DUTIES FOR BOARD MEMBERS

A discussion was held regarding the duties of the board members. The board will be distributing and sharing the duties to best meet the needs of the Village and to save on expenses for the Village.

WATER SAMPLE COLLECTION AND COMMUNITY CENTER CLEANING

Ossowski moved, seconded by Green to terminate the employment of the person collecting the water samples on a monthly basis and cleaning the Community Center. They will be on an on-call basis to meet the needs of cleaning if needed. The water sampling collection will now go to the duties of the Board members. The

transition will take place beginning April 1, 2020. Voting aye: Anderson, Green, Hemenway, Ossowski. Motion carried.

WATER/SEWER/REFUSE DELINQUENCIES

Ossowski moved, seconded by Anderson to approve the recommendation from LRW regarding water/sewer/refuse delinquencies. There are nine customers that have delinquent accounts. We will be locating all stop boxes and if there is not a stop box to be found, we will be putting one in. All offenders who are on the list will be disconnected in a timely manner and will need to pay reconnection fees to have their water turned back on. Voting aye: Anderson, Green, Hemenway, Ossowski. INFORMATION, UPDATES & OTHER DISCUSSIONS

It was brought to the Board's attention that the owners at 5265 Prairie Sage Drive in Roca (aka, Roca Ridge) has been falsely advertising their property as a business for sale. At the request of the Village's attorney, immediate steps were taken to correct or remove these advertisements since there exists no such permit that would authorize such continued use by a new owner. Verizon is in the process of determining if the cemetery is a good location for a tower. They will be on site to determine a possible location as early as this month.
