AGREEMENT FOR MAIN STREET IMPROVEMENT PROJECT

Hemenway moved, seconded by Anderson to approve the permit to put up a fence for Travis Gibbs. All fees were paid by Gibbs. Mr. Gibbs also stated an interest in the land next to him. A discussion was held in regards to owner, cleanup, purchase, etc. Voting aye: Ibsen, Anderson, Green, Hemenway, Ossowski. Motion carried.

Green moved, seconded by Ossowski to approve the permit for Cassandra Manske for a deck/platform that had already been built contingent upon correcting the stairs within 30 days, having the zoning administrator do another inspection and paying \$40.00 for another inspection fee. ROCA RIDGE AND TENT SDL APPLICATION

VIOLATION FEE FOR BEGINNING PROJECT BEFORE PERMIT WAS ISSUED

A discussion was held in regards to the violation fee for starting construction without a permit, enforcing the fee and adjusting the permit process with the Village of Roca.

BRUSH PILE/RECYCLING CENTER – STIPEND

Green moved, seconded by Hemenway to approve a \$100.00 per month stipend to Steve Ossowski to maintain the brush pile gate and to watch the recycling center. Voting aye: Ibsen, Anderson, Green, Hemenway, Ossowski. Motion carried.

BRUSH PILE SURVEILLANCE CAMERAS

An update was given on reviewing the brush pile cameras for seeing who was doing illegal dumping in the area. Signs have been made and will be installed.

LANCASTER RURAL WATER AND WATER METERS

An update was given by Jeff Janda in regards to the new water meters and installation. All of the water meters have been delivered and Larry Lovell and Jeff Janda will begin installing the new radio dial meters next week to businesses and homeowners that are home. They hope to have all of the meters installed to all homeowners of Roca by September 1, 2017. This is the date that Lancaster Rural Water will be taking over the billing also.
